

OFFICIAL EVENT RULES

1. **Sponsorship.** This event is sponsored by Bar Bingo, Inc., with a principal place of business of 12740 Cal Sag Rd. Suite #3 Crestwood, IL 60445 (“Sponsor”) and _____, with a principal place of business of _____ (“Participating Location”).

2. **Games.** There may be anywhere from 5 to 10 total Games (as hereinafter defined) that take place at each Event (as hereinafter defined). For each Game, a participant uses a card or board that contains 5 horizontal rows of spaces, with each row except the central one containing 5 figures. The central row has 4 figures with the word "free" marked in the center space. During each Game, a participant may qualify for the “Flash Prize” award. The Flash Prize is the actual prize played for during each BINGO game. There is no cost involved in redeeming or accepting a Flash Prize. State and federal taxes on prizes over \$600 are the responsibility of the winner. If there is no winner of the Flash Prize, the winner of the Game will receive a consolation prize or “Nightly Prize” which can be in the form of a gift certificate or discount certificate; (a) gift certificate or coupon from the Participating Location at which the Event takes place or (b) gift certificate or coupon from a local merchant with a retail value ranging from \$2.00 to \$25.00. A participant wins a “Standard Game” by completing a combination of 5 spaces in a row, vertically, horizontally, or diagonally based on the numbers drawn randomly by Sponsor through its software system. Each number is displayed on a TV screen at the location. A participant wins a Flash Prize by meeting the following criteria:

a. Special Game #1: A participant wins “Special Game #1” by completing a combination of 5 spaces in a row, vertically, horizontally, or diagonally based on the amount of numbers drawn randomly by Sponsor through its software system. The prize for this game is seasonal and changes every few months. The actual prize and required number draw is announced before the BINGO session begins and at the start of game #1. If there is no winner of the Flash Prize, the winner of the Game will receive the consolation prize or “Nightly Prize” which can be in the form of a gift certificate or discount certificate.

b. Special Game #2: A participant wins “Special Game #2” by completing a combination of 5 spaces in a row, vertically, horizontally, or diagonally based on the amount of numbers drawn to complete the required pattern, as indicated below; drawn randomly by Sponsor through its software system. Winners receive the corresponding VISA gift card.

5 spaces in a row, vertically, horizontally, or diagonally in 11 or 12 numbers wins \$25

5 spaces in a row, vertically, horizontally, or diagonally in 9 or 10 numbers wins \$50

5 spaces in a row, vertically, horizontally, or diagonally in 7 or 8 numbers wins \$100

5 spaces in a row, vertically, horizontally, or diagonally in 11 or 12 numbers wins \$25

5 spaces in a row, vertically, horizontally, or diagonally in 6 numbers wins \$250

5 spaces in a row, vertically, horizontally, or diagonally in 5 numbers wins \$500

If there is no winner of the Flash Prize, the winner of the Game will receive the consolation prize or “Nightly Prize” which can be in the form of a gift certificate or discount certificate.

c. Special Game #3: A participant wins “Special Game #3” by completing a combination of 5 spaces in a row, vertically, horizontally, or diagonally based on the amount of numbers drawn randomly by Sponsor through its software system. The prize for this game is seasonal and changes every few months. The actual prize and required number draw is announced before the BINGO session begins and at the start of game #3. If there is no winner of the Flash Prize, the winner of the Game will receive the consolation prize or “Nightly Prize” which can be in the form of a gift certificate or discount certificate.

- d. Special Game #4 Chicago Vicinity: A participant wins “Special Game #4” by being the first to cover the four outside corners or the four inside corners (the inside corners are the four spaces at the four corners of the free space.) A combination of the inside and outside corners is insufficient. The first player to complete a four corner BINGO will be entered into a drawing that takes place every other month. The winner of this drawing can choose between a Harley Davidson motorcycle (year and model may vary from drawing to drawing) or a \$4,000 cash payout. Winner is responsible for transportation, taxes, licensing and insurance in the event that the motorcycle is chosen. If the winner chooses the \$4,000 cash option, they are responsible for all taxes. The date and location of each drawing will be announced as determined; no later than 14 days before the drawing.

- e. Special Game #4 Non-Chicago Vicinity: A participant wins “Special Game #4” by completing a “picture frame” pattern, which is the entire top and bottom row, along with the entire B and O column, based on the amount of numbers drawn randomly by Sponsor through its software system. The prize for this game is seasonal and changes every few months. The actual prize and required number draw is announced before the BINGO session begins and at the start of game #4. If there is no winner of the Flash Prize, the winner of the Game will receive the consolation prize or “Nightly Prize” which can be in the form of a gift certificate or discount certificate.

- f. Special Game #5: A participant wins “Special Game #5” by being the first to complete a “C” pattern game. This pattern is achieved by covering all 5 numbers on the top of the card, all 5 numbers on the bottom row and all five numbers on the left side of the card (for a total of 15 squares). The prize for this game is seasonal and changes every few months. The actual prize and required number draw is announced before the BINGO session begins and at the start of game #5. If there is no winner of the Flash Prize, the winner of the Game will receive the consolation prize or “Nightly Prize” which can be in the form of a gift certificate or discount certificate.

- g. Special Game #6: A participant wins “Special Game #6” by completing a combination of 5 spaces in a row, vertically, horizontally, or diagonally based on the amount of numbers drawn randomly by Sponsor through its software system. The prize for this game is seasonal and changes every few months. The actual prize and required number draw is announced before the BINGO session begins and at the start of game #6. If there is no winner of the Flash Prize, the winner of the Game will receive the consolation prize or “Nightly Prize” which can be in the form of a gift certificate or discount certificate.

- h. Special Game #7: A participant wins “Special Game #7” by completing a combination of 5 spaces in a row, vertically, horizontally, or diagonally based on the amount of numbers drawn randomly by Sponsor through its software system. The prize for this game is seasonal and changes every few months. The actual prize and required number draw is announced before the BINGO session begins and at the start of game #7. If there is no winner of the Flash Prize, the winner of the Game will receive the consolation prize or “Nightly Prize” which can be in the form of a gift certificate or discount certificate.

- i. Special Game #8: A participant wins “Special Game #8” by completing a combination of 5 spaces in a row, vertically, horizontally, or diagonally based on the amount of numbers drawn randomly by Sponsor through its software system. The prize for this game is seasonal and changes every few months. The actual prize and required number draw is announced before the BINGO session begins and at the start of game #8. If there is no winner of the Flash Prize, the winner of the Game will receive the consolation prize or “Nightly Prize” which can be in the form of a gift certificate or discount certificate.
- j. Special Game #9: A participant wins “Special Game #9” by completing a “Plus Sign” pattern. A Plus Sign pattern is achieved by covering four numbers and free space in the center column of the card, and covering four numbers with free space in the center row of the card, thus forming a plus sign. The actual prize and required number draw is announced before the BINGO session begins and at the start of game #9. If there is no winner of the Flash Prize, the winner of the Game will receive the consolation prize or “Nightly Prize” which can be in the form of a gift certificate or discount certificate.
- k. Special Game #10: A player wins “Blackout Game #10” which is the final game of the session. If a participant succeeds in completing his/her entire card or board (24 numbers with free space) based on the pre-announced numbers to be drawn randomly by Sponsor through its software system. Sponsor will announce the total numbers that will be drawn prior to the start of the Blackout Game. The total numbers that will be drawn are at the sole discretion of the Sponsor and there are generally between 52 and 60 numbers. For the Blackout Game, the value of the cash prize award will be announced prior to the start of the Blackout Game. If there is no winner of the Flash Prize, the winner of the Game will receive the consolation prize or “Nightly Prize” which can be in the form of a gift certificate or discount certificate.

No winner is guaranteed for any Blackout Game. If there is no winner, the cash prize award carries over to the next event at a participating location.

There is no guarantee there will be a winner of any of the Special Games, including the Blackout Game. Each Standard Game, Special Game and the Blackout Game are collectively referred to as the “Games.” An “Event” is defined as the Games that take place at the Participating Location during the scheduled time as published on Sponsor’s website or Participating Location.

3. **Procedures.** During each Event, participants may enter by visiting the Participating Location during the Event and participating in the Game(s). All participants must enter themselves in the Event and each Game; a third-party (including the Sponsor’s employees) may not enter another in the Event or any Game. A participant is limited to one (1) card per Game. In the event that a participant fails to comply with any of the requirements contained in this Section or that are otherwise provided for herein, at the sole determination of the Sponsor, such participant may be disqualified from the Event or any Game. Moreover, at the sole determination of the Sponsor, all of that participant’s entries may be deemed null and void, not honored or acknowledged and may be grounds for forfeiture of his/her prizes.

4. **NO PURCHASE NECESSARY.** NO PURCHASE IS NECESSARY TO ENTER OR WIN THE EVENT OR ANY GAME. FURTHER, A PURCHASE (INCLUDING, WITHOUT LIMITATION, PLAY OF VIDEO GAMING TERMINALS OR THE PURCHASE OF ANY PRODUCT, GOOD OR SERVICE SOLD BY THE SPONSOR OR THE PARTICIPATING LOCATION) WILL NOT IMPROVE A PARTICIPANT’S CHANCES OF WINNING WITH AN ENTRY.

5. **Prizes, Prize Values, Odds of Winning and Collecting Prizes.**

- (a) It is the participant's responsibility to read and understand all information, if any, which accompanies any prize concerning use, risks and maintenance. No winner may substitute his/her prize. All taxes on the prizes, if any, are each winner's responsibility. Each Sponsor reserve the right to substitute a prize for an item of equivalent or greater value if the prize specified is unavailable for any reason.
- (b) The odds of winning each Game and corresponding prize is dependent entirely on the number of cards or boards in play for each Game as well as the Special Game criteria, as set forth above. For any number of boards (1, 50, or other), the probability of getting a Bingo when the Nth number is called is the difference between the cumulative probability for the Nth number and the (N-1)th number.
- (c) Winners must be present. Each winner will be able to collect his/her prize for a Standard Game at the Participating Location at the Event. All prizes awarded for a Special Game, including the Blackout Game, may be collected by participant at the Participating Location where it was won the following week. Because all prizes must be collected in person at the Participating Location, there are no shipping or handling fees or charges associated with collecting a prize. If alternative arrangements are made to ship a prize to participant, participant is responsible for all shipping and handling fees associated with collecting the prize.

6. **Eligibility.** Each Event is open to all legal residents of the United States of America who are twenty-one (21) years or older at the time of entry. Owners of locations where event is conducted are not eligible to play at that location. Employees of an event location are not eligible to play while actively on duty. Employees of Sponsor are not eligible.

7. **Use of Disclosed Information.** Information transmitted to any Sponsor will generally be treated as non-confidential and non-proprietary. Except where prohibited by law, entry constitutes permission to use each winner's name, biographical information and/or likeness for online posting and/or any other written or photographic advertising and publicity without additional compensation. Further, by entering the Event, the Participant is granting each Sponsor permission to use his/her contact information to provide him/her with marketing or other informational materials related to a Sponsor.

8. **Facebook Disclosure.** Although an Event may be advertised on the Facebook pages of either Sponsor or Participating Location, no Event is in any way sponsored, endorsed or administered by, or associated with, Facebook. Participants are providing their information to each Sponsor and not to Facebook. The information a participant provides will only be used by a Sponsor. By entering, participants provide a complete release of Facebook from any and all responsibilities implied or provided by a Sponsor and that this Event is in no way sponsored, endorsed or administered by, or associated with, Facebook.

9. **Miscellaneous.**

- (a) By entering, participants unconditionally agree to be bound by these rules and the decisions of the Sponsor, which shall be final. Each Sponsor reserve the right to disqualify any participant or winner who, in its sole suspicion, tampers with the entry process, violates these rules, or acts in an unsportsmanlike or disruptive manner.
- (b) All federal, state, and local laws apply.
- (c) Each Sponsor and, as applicable, the employees, officers, directors, shareholders, agents, and representatives of the Sponsor, their affiliates, subsidiaries, and advertising, promotion and legal advisors are not responsible for and shall not be liable for: (i) late, lost, delayed, damaged, misdirected, incomplete, illegible, or unintelligible entries; (ii) any condition caused by events beyond the control of any Sponsor that may cause the Event to be disrupted or discontinued; (iii) any injuries, losses, or damages of any kind caused by a prize or resulting from acceptance, possession, or use of a prize, or from participation in the Event; or (iv) any printing or typographical errors in any materials associated with the Event.
- (d) Participants agree that any dispute arising out of this Event shall be resolved individually without class action and exclusively by the state and federal courts in Cook County, Illinois under the laws of Illinois, without regard to that state's conflict of laws principles.
- (e) For the name of the winners or an additional copy of the Official Rules, send a self-addressed stamped envelope request to the Sponsor at its principal place of business identified in Section 1 above. The names of the winners will be available on or after three (3:00pm) the day immediately following the Event.
